Report of the Demographics Committee to the Pupil Services Committee of the West Chester Area School Board

March 16, 1998

ABSTRACT

This report has been developed by a 23 member Demographics Committee formed in January, 1998. This committee has worked for several months to prepare this proposal for the Pupil Services Committee of the West Chester Area School Board.

The goal of the committee was "to establish attendance areas which will provide optimal learning and building usage for all students in the West Chester Area School District." With a list of nine objectives to be achieved in meeting this goal, we have developed a proposal which meets the needs of the projected enrollment growth for the next three years, 1998 - 2001. Since Chester County is one of the fastest growing counties in the United States, there are many areas in the school district where "hot spot" growth is expected to occur during the next three years.

This proposal impacts seven of the ten elementary schools. Our recommendations adjust the middle school boundaries to accommodate the existing enrollment imbalance. The current projections predict that Fugett and Peirce Middle Schools will be at their capacities by 1999 - 2000. The recommended moves will impact Stetson, Fugett and Peirce Middle Schools by providing some relief. One recommended move results in a middle school feeder system change for students from Peirce to Stetson Middle School. Borough moves recommended include students from Hillsdale to Starkweather Elementary, and some East Goshen Elementary students living in the borough who now attend Fugett Middle School are recommended to attend Stetson Middle School.

A total of 212 students are recommended to be moved, consisting of 169 elementary and 43 middle school students. This represents only 1.8% of the total district enrollment. The committee is especially proud that no children who were moved as a result of the 1994-95 redistricting recommendations are included in our proposed changes.

Twelve recommendations are included in this report as a result of our study. The most significant recommendations are to move two relocatable classrooms, adding four classrooms at Peirce Middle School, adding two classrooms at Fugett Middle School, and adding Abstract Page 2

two classrooms at Stetson Middle School. Additionally, the committee strongly urges the Board to activate the proposed Capital Fund Project at East High School and to add a minimum of six classrooms at both East and Henderson High Schools to accommodate the rapid enrollment growth.

The projected cost for all of the recommendations in this proposal is anticipated to be approximately \$2,240,000.

DEMOGRAPHICS COMMITTEE 1997-98 METHODOLOGY

- With information supplied by the school district we identified all students in each school by street address, by grade level, by ethnic group, and by neighborhood. This information allowed us to know exactly how many children would be affected by a recommended move.
- We studied the work of the previous demographics committees in order to learn from their experiences and not reinvent the wheel.
- We identified all areas moved three years ago.
- We researched currently known and potential areas of growth.

- We studied each existing elementary, middle and high school boundary to become familiar with attendance areas in the entire district.
- We calculated the capacity in each school, including the relocatable classrooms already in use.
- In order to provide program equity rooms for special education, art, music and computers were not counted in determination of capacity.
- We compared the enrollment projections prepared by the West Chester Area School District, the Pennsylvania Department of Education, and the Waetzmann Study, which was commissioned as a result of the work of the 94/95 Demographics Committee. In comparing this data with actual student enrollment, it was clear that the projections of the West Chester Area School District have

historically been the most accurate. In fact, over the course of the last four years they were accurate within 2%, and accordingly, we chose to use the West Chester Area School District figures in our determinations.


